Asia-Pacific Trade Economists' Conference: Trade-Led Growth in Times of Crisis

5th Anniversary Conference of ARTNeT



ARTNeT welcomed some 135 trade researchers and policymakers from the Asia-Pacific region and beyond for the celebration of its 5th Anniversary Conference on the topic of *Trade-Led Growth in Times of Crisis* on 2 and 3 November in Bangkok, Thailand.

During the plenary sessions, conference participants discussed the origins of the global economic crisis and its implications for the Asia-Pacific region. The **trade-led growth model followed by many countries in the region was not fundamentally challenged**, though it was suggested that developing countries should rebalance the geographic and product structure of their trade in order to diversify their sources of growth.

Conference participants also stressed the need for governments to **invest more in social programmes** and

called for more **political leadership on trade matters coming from the Asia-Pacific region** to provide new impetus to the negotiations of the Doha Development Agenda. ARTNeT Third Multi-stakeholder Steering Committee Meeting



The Third ARTNeT Multi-stakeholder Steering Committee was convened on 1 November 2009 in Bangkok to review past ARTNeT activities and to discuss future research priorities. The policymakers and researchers who attended the meeting discussed ways to better link policymaking and research and to tailor capacity-building activities to the needs of research institutions. Participants also encouraged the Secretariat to promote closer partnerships among ARTNeT members and policymakers.

Research Workshop on Rising Non-Tariff Protectionism and Crisis Recovery



A research workshop on non-tariff protectionism and crisis recovery was held in Macao, China on 15 and 16 December 2009 under the Macao Regional Knowledge Hub (MARKHUB) research workshop series sponsored by the Government of Macao, China, in cooperation with UNCTAD, the World Trade Organization and ESCAP.

The workshop focused on the study and discussion of the non-tariff based protectionism affecting developing and the least developed countries of the region. 9 policymakers from 7 Asian countries and 29 researchers from 24 research and government institutions participated in the event. Launch of new ARTNeT Regional Trade Facilitation Study on

Enhancing Regional Import-Export Procedures and Processes

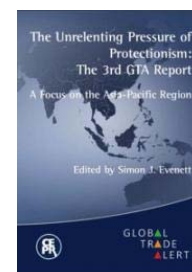
A new trade facilitation study was launched in November 2009 to conduct a detailed analysis of export processes for specific products (e.g. garments, cotton, shrimp, auto parts, etc.), identify relevant procedures and processes and map these processes using Business Process Analysis methods, and estimate time and costs of the relevant procedures and processes for exporters.

Researchers from ARTNeT member institutions in seven countries were selected to contribute to the study (China, Bangladesh, India, Japan, Nepal, Sri Lanka and Thailand). A first research team meeting was organized on 23-24 November 2009 in Bangkok to discuss methodologies and implementation.

ARTNeT Advisors for the study include Mema Beye of the World Bank's Doing Business Team as well as H.E. Sok Siphana, Advisor to the Royal Government of Cambodia. This new initiative is an attempt to bridge trade facilitation research and implementation, and to deliver actionable analytical results, in collaboration with the United Nations Network of Experts for Paperless Trade (UNNEXT).
